Course Objective

Enrollment Eligibility

Graduate students with at least one year of graduate-school enrollment, and with preliminary data from their research.

Gender and pronouns, Modifiers, Idioms, Jargon, Nouns from verbs, Collectives, Spelling, Similar words with different meanings

8. Sentences

Active and passive voice, Tense, Parallel structure, Double negatives, Complex sentences, Wordiness, Transition, Punctuation marks

9. Preparing the Manuscript

10. Dealing with the Journal

Selecting a journal, Submitting the manuscript, Peer review, Communications from the journal, When a paper is not accepted, Proof correction
